

# Gamers.bet User End License Agreement (UELA)

**Notice:** This User End License Agreement (“Agreement” or “UELA”) is provided in draft form for regulatory, compliance, and payment provider review purposes. The final version of this Agreement will be delivered prior to public launch. Upon acceptance by a user, the then-current version of the Agreement will constitute a legally binding agreement between the user and Gamers.bet Inc.

## 1. License Grant

Subject to your compliance with this Agreement and the Gamers.bet Terms of Service, Gamers.bet grants you a limited, non-exclusive, non-transferable, non-sublicensable, revocable license to access and use the Platform solely for personal, lawful purposes.

This license does not grant you any ownership interest in the Platform or any related intellectual property.

## 2. Platform Role and Scope

Gamers.bet provides infrastructure that enables skill-based, real-money competitive gameplay within third-party games. Gamers.bet does not operate or control gameplay mechanics, scoring logic, player performance, or game outcomes.

Third-party game developers and publishers are solely responsible for their games, including gameplay design, rules, scoring, and results. Gamers.bet relies on game-submitted results to perform settlement and platform functions.

## 3. Restrictions

You may not, directly or indirectly: - Copy, modify, adapt, translate, or create derivative works of the Platform - Reverse engineer, decompile, disassemble, or attempt to derive source code or settlement logic - Circumvent, disable, or interfere with security features or access controls - Use automation, bots, scripts, or unauthorized tools to access or interact with the Platform - Use the Platform for unlawful purposes or in violation of applicable law - Exploit bugs, vulnerabilities, or errors for competitive or financial advantage

## 4. Third-Party Games and Content

The Platform integrates with third-party games and services. Gamers.bet does not own, license, or control third-party game content unless explicitly stated.

Your use of any third-party game is subject to that game's terms, policies, and licenses. Gamers.bet is not responsible for third-party content, availability, or conduct.

## 5. Updates and Modifications

Gamers.bet may update, modify, suspend, or discontinue the Platform or any portion thereof at any time, with or without notice, subject to applicable law.

Gamers.bet may also update this Agreement from time to time. Continued use of the Platform constitutes acceptance of the revised Agreement.

## 6. Intellectual Property

All rights, title, and interest in and to the Platform, including software, code, algorithms, settlement systems, documentation, trademarks, logos, and branding, are owned by Gamers.bet or its licensors and are protected by applicable intellectual property laws.

Nothing in this Agreement grants you any right to use Gamers.bet's intellectual property except as expressly permitted herein.

## 7. Suspension and Termination

Gamers.bet may suspend or terminate your access to the Platform at any time for violations of this Agreement, the Terms of Service, suspected fraud, compliance requirements, or legal obligations.

Upon termination, all licenses granted under this Agreement immediately terminate, and you must cease all use of the Platform.

This Agreement shall be governed by and construed in accordance with the laws of the State of Delaware, USA, without regard to conflict of law principles.

Any disputes arising out of or relating to this Agreement shall be resolved through binding arbitration, except where prohibited by law.

If any provision of this Agreement is held to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

## 12. Entire Agreement

This Agreement, together with the Gamers.bet Terms of Service and Privacy Policy, constitutes the entire agreement between you and Gamers.bet regarding use of the Platform and supersedes all prior or contemporaneous agreements or understandings.
